Repeater Committee

Dave N1HAC reported that the Moose Mt. repeater 220 radio has been repaired. The 220 duplexer has been tweaked with good specs. 90dB rejection. There will be final testing and the volume will be turned down. The finals have been blown out, the possible cause being the antenna. The output modules were swapped. Dave N1HAC wants to spend \$35.00 for a new spare power amp module. To be dealt with in new business.

2M sensitivity is down again, will look at tomorrow. An intermittent cable problem? May be de-sensed by collocated equipment. 5G antennas? Dave WA1ZCN thinks it is an equipment problem.

The portable repeater needs work. Dave N1HAC talked to an S-COM designer at Hamvention. They are working on replacement. He mentioned missing on air voice programming. The response was digitizing implementation could put that feature in. Dave WA1ZCN reported that the RC-100 control board is good but the codes won't go in. He will reread to figure it out. Have other controllers to use.

Dave WA1ZCN reported revision of the volume controls in the communication trailer. A better alternative has been ordered. The other parts kept getting back ordered. He proposed the alternative being an in line audio control in a box. Ed AB1XQ stated that other options are available for the same money and a better fit is possible at \$40.00.

Alan AE1H made a motion to authorize spending up to \$40.00 for the volume control parts. Dave N1HAC seconded the motion. *The motion passed unanimously*.

Dave WA1ZCN reported that the ARRL posters printed by Vistaprint were delivered with minor damage. Vistaprint will replace these. The damaged posters will be given to the section. These were reviewed.

Dave N1HAC reported the need to spend \$34.65 for a new spare power amp module. Alan AE1H made a motion to authorize spending up to \$35.00 for the module. Kim KE1LF seconded the motion. *The motion passed unanimously*.

Nicole AC1HQ brought up using the club poster at the Big E and asked about club interest in manning the booth there at Vermont Day, as was done last year. There was discussion. Moving the booth will not happen, there was push-back. Dave WA1ZCN stated that the booth looks more professional.

With no further business to address a motion to adjourn called for. So moved by Alan AE1H, seconded by Dave N1HAC. *The motion passed unanimously*.
